Competition will consist of eight events: Open Stone, Braemar Stone, Heavy & Light Hammers, Heavy & Light Weight for Distance, Caber & Weight for Height. Athletes must participate in all events to qualify for the overall award. Aggregate ties will be broke with the Heavy Weight for Distance score. WFH ties will be broke using all previous misses if needed.

### Rules:

- Competition will be conducted in accordance to SAAA rules.
- All athletes must wear a kilt during competition, some rentals available.
- Check-in time for all athletes begins at 8:00am at the Heavy Events field tent and will close promptly at 9:00am. Competition starts at 9:30.
- Field registration entries accepted on a space available basis only. Field entry: \$30
